Member Rights:

1. Members of the PEI Literacy Alliance shall be organizations passionate about building a culture of literacy, learning and prosperity on PEI.
2. Member organizations may be required to pay an annual fee or fees as established by the Directors of the PEI Literacy Alliance.
3. Each member organization may appoint a representative to attend, speak and vote on behalf of the organization at the PEI Literacy Alliance general meetings.
4. Rights of Member Organizations: Every Member Organization has the right to:
 - a. attend, speak, and have one vote at all general meetings, notwithstanding exceptions because of conflict of interest
 - b. nominate a representative to be elected as a Director
 - c. replace its representative if he or she is elected to the Board of Directors
 - d. receive minutes of annual meetings, the financial audit, newsletters, and other reports produced by the PEI Literacy Alliance
 - e. take part in the election of Directors through its representative
5. Organizational membership in the PEI Literacy Alliance is not transferable. Any member may resign from membership upon notice in writing to the Alliance.
